

What We've Heard So Far - Objectives

Community Engagement Objectives:

- Confirm the Task Force's recommendations
- Test assumptions the Task Force has about recommendations and outcomes they would produce. What would actually change behavior, build trust with the health care system? Would this move engagement? If these recommendations went into effect, would the public have trust in the health care system? Which recommendations are most important to change health equity?
- Ask what is missing from the recommendations
- Ask what health care equity models are/not working and why
- Invite feedback from organizations expected to implement Task Force recommendations. What are you going to need? What will it take for you to implement and right-size recommendations? What will you need from MDH? How will you balance recommendations with other constraints?

What We've Heard So Far – Engagement Ideas

Activity ideas:

- In-person and/or virtual community and public input events including listening sessions, focus groups, round tables; facilitated by Alliant, supported by multiple Task Force Members
- Interviews and 1:1s; facilitated by Alliant, supported by 1-2 Task Force Members
- Community panel during Task Force meeting
- Public written comment
- Survey

Important note: it will be important to "close the feedback loop" on these engagement activities and report outcomes back to those who gave their input

Community Engagement Plan – The How

- Events for specific stakeholder groups (provider, payer, patient/public)
 - Focus groups for those stakeholders whose input is needed to "test" feasibility of a recommendation
 - Roundtables for small groups of stakeholders to engage in a group feedback discussion
 - Listening sessions to present formed recommendations for feedback
 - Interviews for those stakeholders that may present specialized feedback
- Consider specific communities that may require their own event in order to comfortably provide input
- Consider plugging into existing events to invite input

Community Engagement Plan – The Who

- Specific stakeholder groups such as patients, providers, payers, and councils
- Organizations representing, serving and advocating for communities impacted by health care disparities
- Health care leaders, board members, professionals
- Community groups as represented by Task Force members
- Specific organizations/individuals
- Patients/general public



Community Engagement - Other Considerations

- Include a broad diversity of stakeholder groups (large, small, rural, urban, spanning Minnesota geographies and demographics)
- Daytime and evening events to give stakeholders options to attend
- Constraints of time
 - To have recommendations developed
 - To plan and organize the number and type of events
 - To close the feedback loop from participants

- Member connections to any of the listed groups to facilitate introductions and support engagement events


Next Steps
