The clinic is affiliated with a particular care system. Members can see a specialist in their care system without a referral. Members who need to see a doctor who's in the Medica Elect network but isn't in their care system can request a referral from their primary care clinic. If members need to see a provider outside the Medica Elect network, they can request a referral from their primary care clinic and pre-approval (called "prior authorization") from Medica.
