- Special Needs Plan (SNP) The plan integrates and provides both Medicaid and Medicare services.
- Non-Special Needs Plan (Non-SNP) The plan provides Medicaid services only and Medicare is provided fee for service.

Audit Designation & Rate Status

All measures selected for public reporting must have a final, audited result. The auditor approves the rate or report status of each measure and survey included in the audit, as shown below.
