# **Background**

The Medical Education and Research Costs (MERC) Program was established in 1996 to address the need for and importance of investing in medical education to maintain a high-quality health care system for all Minnesotans. Training health care clinicians is an expensive endeavor, and historically, teaching institutions offset some of these costs by charging higher rates for patient care. However, as the health care market became increasingly competitive, it became increasingly challenging for teaching facilities, which had to compete with non-teaching institutions, to fund educational activities. The MERC program provides vital support and funding for these teaching activities.

Since its inception and first year of funding in 1997, the program has distributed over \$1.2 billion to hospitals, clinics, and other clinical training facilities across Minnesota, helping to offset the costs of training health professionals.

Historically, a large portion of the funding for the MERC program was approved through a federal Medicaid 1115 waiver, which was extended through 2022, but not renewed by CMS. In response, changes to legislation were introduced during the 2023 legislative session to secure CMS approval for the former PMAP carveout. Prior to the 2023 changes, funding available under the 1115 waiver was allocated to the Minnesota Department of Health for distribution to all eligible sites via the MERC program. Under the revised legislation, these funds are no longer allocated through the Department of Health; however, MERC-eligible hospitals and sites affiliated with hospital systems potentially could qualify for supplemental payments through a medical education component integrated into Medicaid FFS hospital rates. While these projected payments are still determined using the MERC formula, the Department of Human Services is responsible for setting rates and administering funding and payments for these funds.

The portion of MERC funding that was not impacted by the 1115 waiver continues to be administered by the Department of Health. To minimize the impact of the changes on sites that are no longer eligible for the former PMAP carveout—sites that are not hospitals or affiliated with a hospital system, the 2023 legislation included provisions to exclude hospitals and sites affiliated with a hospital system from the portion of funding that comes from the general fund and the health care access fund.

Funding continues to be determined using a distribution formula outlined in Minnesota Statutes, section 62J.692. This formula calculates the total Medicaid revenue pool across eligible sites and determines the percentage of Medicaid revenue attributed to each clinical training facility. This percentage is then applied to the available funding to calculate each facility's allocation.

A facility's funding cannot exceed its reported clinical training expenditures, nor can it surpass the 95th percentile award per FTE cap. Facilities must provide clinical training to a minimum of 0.1 FTE trainees, which is equivalent to providing 208 clinical hours of training. Those sites that would receive awards below \$5,000 are ineligible for MERC funding, and their share of allocated funds are redistributed among qualifying facilities.

Over the years, the formula has evolved in response to varying perspectives and priorities. The debate has generally centered on whether the program should prioritize supporting clinical training wherever it occurs or focus on facilities with a larger share of Medicaid business. The argument for funding where training occurs is rooted in a cost-based formula, which directs funds to facilities that train the highest number of students or residents and therefore incur the highest costs. The argument for prioritizing Medicaid-focused facilities stems from the program's reliance on Medicaid funds, maintaining that funding should primarily support facilities with a greater share of Medicaid business.

# Reporting

Throughout this report, the current funding year corresponds to state fiscal year 2025, while the 'data year' refers to fiscal year 2023 clinical training, which serves as the reference year for data used to calculate funding amounts. For clarity, numbers are rounded for reporting purposes.

# **Funding**

Funding is divided into three distinct formula pools, each governed by specific eligibility criteria. The MERC formula is applied individually to each pool, ensuring that funding calculations address the legislation of each. Additionally, the overall \$5,000 minimum funding requirement is assessed as the combined total across all three pools.




Figure 1 – Funding and Formula Pools

## All Eligible Applicants – Formula Pool 1

The first pool includes an appropriation of \$3,788,000 from Minnesota's cigarette tax, along with \$3,875,370 in federal matching funds. The maximum combined state and federal match allowed under the State Plan Amendment is \$7,575,000. Due to an enhanced match rate, \$88,370 of the original cigarette tax funds are unmatched.

All MERC applicants who met the minimum application requirements were included in Pool 1.

## **Excludes Hospitals & Affiliates - Formula Pool 2**

The second pool consists of \$1 million from the state general fund and \$1 million from the state health care access fund.

Clinical training sites that were eligible for the first pool and are not hospitals or affiliated with a hospital system were also considered for the second pool if they reported clinical training expenditures that exceeded their Pool 1 allocation. Hospitals and sites affiliated with hospital systems were not eligible for Pool 2.

## **Exclusive to Hospitals & Affiliates - Formula Pool 3**

The third pool includes \$49,552,000 that will be integrated into a medical education component in Medicaid FFS hospital rates between July 1, 2025, to June 30, 2027. While the MDH MERC program determines the projected funding allocation, the Minnesota Department of Human Services (DHS) will manage rates, and payments. The MERC determinations are made on an annual basis, but hospital payment rate will be aligned with the two-year Medicaid rate-setting and payment cycle. In the illustration above, the current 2023 application cycle will be combined with the upcoming 2024 application cycle. Together, the funding from two clinical training application cycles totals \$99,104,000, with payments averaged across the two-year rate period.

Hospital and hospital affiliated clinical training sites that were eligible for the first pool were also considered for the third pool if their reported clinical training expenditures exceeded their Pool 1 allocation. Pool 3 was limited to hospitals or sites affiliated with a hospital system that qualified for MERC.

# **Application Process**

Applications for clinical training in Minnesota are submitted to the Minnesota Department of Health by sponsoring institutions. These sponsoring institutions coordinate the process on behalf of their accredited teaching programs and the facilities providing clinical training for the program's trainees.

# **Applicants and Award Recipients**

## **Sponsoring Institutions**

In total, 27 sponsoring institutions submitted MERC applications. These sponsoring institutions were applying on behalf of 322 teaching programs whose students/residents received clinical training in Minnesota during the teaching programs' 2023 fiscal year.

Since funding is designed to offset costs at clinical training facilities, the sponsoring institutions are required to pass available funds on to eligible facilities where the students or residents clinical training was provided within 60 days of receipt. Prior to the 2023 legislative changes, MERC funding was distributed to the clinical training site solely through the sponsoring institution. Under the new mechanism, only funding from Pool 1 and Pool 2 continue to pass through the site's sponsoring institution. Those payments were distributed in April 2025. The funding attributed to the medical education component from Pool 3 will be distributed directly to the sponsor's eligible training sites through a component in the site's Medicaid FFS hospital rates.

Many entities in Minnesota are both sponsoring institutions and training sites.

## **Training Facility Types**

Training occurs across a wide variety of settings, with Medicaid playing a significant role in determining funding outcomes. Medical Assistance (MA) and Prepaid Medical Assistance Program (PMAP) revenue are used to calculate initial funding at the facility level. The costs associated with clinical training and the number of trainees then help allocate funding to specific trainee types and teaching programs. The effect of the role of Medicaid in the formula is particularly evident with dental facilities, which host a substantial number of trainees but receive a significantly lower allocation per FTE compared to other facility types with higher Medicaid volumes.

## **County**

Consistently, most clinical training has taken place in Hennepin County and Olmsted County. However, the largest portion of funding is allocated to facilities in Hennepin County and Ramsey County, aligning with the counties' share of Medicaid. The figures below provide a comparison of the relative percentages of trainees, expenditures, Medicaid (MA/PMAP) reimbursements, and MERC funding.





Figure 3 – Clinical Training in Urban vs Rural Facilities

Figure 3A – Clinical Training in the Seven County Metro






Figure 3B – Top Rural Counties Receiving Funds for Clinical Training

### **Clinical Training Facilities**

As noted earlier in the report, MDH received applications from 27 sponsoring institutions representing 322 teaching programs and their respective clinical training facilities. These applications included funding requests for 484 distinct facilities, which hosted trainees from various teaching disciplines.

To be eligible for MERC funding, a training facility must meet three criteria: host at least 0.1 FTE clinical trainees from an eligible accredited program, report clinical training expenditures of \$5,000 or more, and provide patient care resulting in Medical Assistance or Prepaid Medical Assistance Program reimbursement during the training year. A total of 130 facilities did not meet these initial qualifications, with the majority (85) falling short of the FTE requirement.

Of the training facilities that met the initial qualifications, 294 were funded. The remaining 60 did not qualify due to the formula calculation, which determined initial funding below the \$5,000 minimum threshold. Facilities that fail to meet the minimum typically have smaller shares of Medical Assistance and Prepaid Medical Assistance Program revenue compared to other applicants.

In 2023, MERC training sites provided clinical training to over 3,301 FTE trainees. The number of trainees that a facility hosts can vary year to year—some facilities that hosted trainees in 2023 had not hosted trainees in the previous training period. Table 5 details the total number of qualifying facilities and FTEs within the specific range.

A total of 190 sites were ineligible due to not meeting either the \$5,000 minimum or the initial qualifications.

Table 6 includes the top 25 recipients, collectively accounting for nearly 81 percent of the total funding and hosting nearly 81 percent of the trainees.

A relatively small number of clinical training sites account for the majority of training supported by MERC funding. Twenty-five facilities hosted at least 10 FTEs, these facilities represented nearly 88 percent of the qualifying FTEs trained in Minnesota and received 75 percent of the available funds. Of these, six facilities hosted more than 150 FTEs, accounting for just over 73 percent of the qualifying trainees in Minnesota and receiving just over 37 percent of the available funding. Since funding is based on relative Medicaid volume, rather than on number of FTE trainees, the funding per FTE trainee varies significantly across facilities.

#### **Training Expenditures**

The MERC formula places a cap on the funding an organization can receive, ensuring that support does not exceed the cost of providing clinical training to eligible trainees. This provision was enacted in 2013 to ensure funding is focused on supporting the cost of training. While a site's funding is capped at its total expenditures across various training programs, funds are initially determined based on the facility's relative Medicaid (MA/PMAP) reimbursement. Expenditure limits can encourage training facilities to take on additional trainees when their Medicaid volume is high, and their previous trainee count is low. However, larger facilities with expenditures exceeding award amounts will not see an increase in funding by adding new provider types or trainees.

Minnesota clinical training facilities submitted over \$585 million in training-related expenses for MERC funding. In a typical funding cycle, MERC historically covered between 13-17% of the reported health professions expenditures. Due to higher reported expenses that have been reported since 2022, MERC funding now covers a smaller portion of reported costs compared to previous cycles.




Figure 4 - Overall 2023 Clinical Training Expenditures vs Available 2025 Funding

The impact of MERC funding on clinical training expenditures varies significantly by facility type. Facility types hosting 20 or more trainees are highlighted in the figure below. Hospitals accounted for just over 77% of the total reported training expenditures in Minnesota and received slightly more than 85% of the available funding; however, their actual reimbursement for reported expenditures was only 11.1%.

In contrast, pharmacies contributed just over 0.76% of overall reported training expenditures and received slightly more than 4.7% of MERC funds, with a reimbursement rate of nearly 63%. With many variables at play, adjustments to any applicant or changes to one part of the formula can significantly influence outcomes.




Figure 4A - Facilities Hosting Over 20 FTE Trainees

In the current distribution, a total of 119 facilities received full funding. Without the expenditure cap, 91 of these facilities would have been allocated higher awards, with excess funding amounts ranging from \$500 to \$2.8 million.

The expenditure cap resulted in a redistribution of more than \$7.9 million from the initial allocation of these 91 facilities. These funds were redirected to training sites whose initial funding levels fell short of their actual expenditures. As a result, an additional 28 sites had their expenditures covered. Through this redistribution, nearly \$268,000 was allocated to these 28 sites, increasing their initial funding by amounts ranging from \$493 to \$112,553. This adjustment ensured that their revised funding levels aligned with the limits set by the expenditure cap.

# **Conclusion and Next Steps**

Since its launch in August 2019, the application portal has significantly enhanced program efficiency by collecting data electronically, streamlining processes and providing reporting capabilities.

For more than 25 years, the MERC program has played a vital role in supporting clinical training across Minnesota. As part of a broader initiative, it continues to strengthen the state's health care workforce, ensuring adaptability to evolving payment systems, care delivery models, and training needs.

The recent legislative changes introduced additional complexity to the funding process, changing what had been a single annual formula into a separate calculation process for each applicant pool with payments for hospital and hospital affiliates spread out over a multi-year process.

This complexity is particularly evident in how funding minimums interact with expenditure limits. Total funding across the three pools cannot exceed a site's reported expenditures, and funds from sites failing to meet the \$5,000 minimum must be redistributed to eligible sites. Redistribution is only permitted if it does not push a site's total funding across all three pools beyond its reported expenditures.

The distribution mechanism has also evolved. Historically, funds were allocated annually in April and passed through sponsoring institutions, which then directed awards to clinical training sites. While this method remains for the two smaller pools, the largest pool is now incorporated as a component in Medicaid FFS hospital rates. These rates are determined by combining results from two MERC application cycles, which will influence rates for the period of July 1, 2027, to June 30, 2029.

Determining the formula's broader impact on training volume, location, and sustainability remains a challenge. A facility's funding does not necessarily increase when a new provider type begins training there, despite rising costs. Unless Medicaid revenue increases simultaneously or the facility was previously capped at its clinical training expenditures, funding levels are unlikely to change. Similarly, larger facilities with expenditures exceeding their awards will not receive additional funds for taking on more trainees or provider types.

Medical education funding is crucial for maintaining clinical training opportunities, helping facilities navigate financial pressures and reducing the risk of closures which could delay education, exacerbate workforce shortages, and compound shortages in the health care workforce.

Moving forward, MDH remains committed to collaborating with stakeholders to:

- Improve reporting capabilities,
- Streamline application and distribution processes, and
- Strengthen MERC's role in building a responsive, forward-thinking system that ensures clinical training opportunities for Minnesota's future health care professionals.
