## Minnesota Vaccines for Children (MnVFC) Program

**Provided by:** The Minnesota Department of Health with federal funding.

**Population served:** Children (0 through 18 years) who fall within any of these categories:

- Uninsured.
- American Indian/Alaskan Native.
- Covered by a Minnesota Health Care Program (MHCP) including:
  - Fee-for-service Medical Assistance (MA).
  - MinnesotaCare (MnCare).
  - Prepaid Medical Assistance Plan (PMAP).
- Underinsured<sup>1</sup>

**Providers:** Must be enrolled in MnVFC.

**Vaccine ordering:** All ACIP-recommended childhood vaccines may be ordered via the Minnesota Immunization Information Connection (MIIC).

## Uninsured and Underinsured Adult Vaccine (UUAV) Program

**Provided by:** The Minnesota Department of Health with federal funding.

**Population served:** Adults (19 years and older) in these categories:

- Uninsured
- Underinsured<sup>1</sup>

**Note:** Adults on a Minnesota Health Care Program (MHCP) are **not** eligible.

**Providers:** Must be enrolled in UUAV.

**Vaccine ordering:** Participating sites can order adult vaccines via the Minnesota Immunization Information Connection (MIIC).

### Patient Eligibility for MDH Vaccine Programs

Eligibility	MnVFC Program Pediatric (0 through 18 years)	UUAV Program Adult (19 years and up)
MHCP-enrolled	Yes, all ACIP-recommended childhood vaccines.	Not eligible. Use private vaccine and bill MHCP.
Uninsured	Yes, all ACIP-recommended childhood vaccines.	Yes, certain adult vaccines are available at sites that participate in the UUAV program.

Eligibility	MnVFC Program Pediatric (0 through 18 years)	UUAV Program Adult (19 years and up)
Underinsured <sup>1</sup>	Only at LPH, FQHC, RHC, tribal health, and IHS clinics for all ACIP-recommended childhood vaccines.	Yes, certain adult vaccines are available at sites that participate in the UUAV program.
American Indian or Alaskan Native	Yes, all ACIP-recommended childhood vaccines.	Not applicable. Vaccinate based on insurance status.
Insured (private/commercial)	Not eligible. Use private vaccine and bill private insurance.	Not eligible. Use private vaccine and bill private insurance.

<sup>1</sup> Underinsured is defined as patients with private insurance that does not cover the vaccine itself or has a cap.
